

ILT FOUNDATION POLICY

NZ REPRESENTATIVE SCHOLARSHIP POLICY

An ILT Foundation NZ Representative Scholarship provides financial support towards travel and accommodation costs incurred by an individual in order to travel to compete as a NZ Representative in any field.

SCHOLARSHIP CRITERIA

Applicants are required to demonstrate that they have been **selected to represent NZ** in their chosen field.

Eligibility:

Applicants of any age are eligible. They must be New Zealand citizens currently residing within the ILT Foundation boundary. "Currently residing in Invercargill" includes those New Zealand citizens who are attending tertiary study or a recognized training programme during term time, who return to live at home with their parents who reside in Invercargill during study/programme breaks. Consideration will be given to applicants residing outside Invercargill who have left the province within the last three years, and whose immediate family still reside in Invercargill. Residency in Invercargill must be for a minimum of 12 months.

It is expected that any applicant is an amateur.

Applicants shall provide the following information:

- A completed Scholarship Application Form with appropriate attachments.
- The application should be accompanied by a letter from the governing body of the entity / organisation / sport code advising the applicant has been selected to represent NZ.

The scholarship application is required to be supported and submitted through a local not-for-profit organisation.

Scholarship Decisions:

- The amount of the scholarship is to be determined by the ILT Foundation Trustees.
- An applicant may apply once for any event they are a representative of New Zealand in any one year. If they are selected for a further event during that year, they may apply for another scholarship.

Timing:

- Applications must be received in time for Trustees consideration, prior to the commencement of the event the NZ representative is to attend.
- Funding applications are considered as necessary.

Payment of Scholarship:

Scholarship funding will be paid once the scholarship has been approved.

Scholarship Accountability:

- It is intended that the scholarship funds may be used towards travel and accommodation, including overseas travel and accommodation.
- Organisations who apply for the scholarship funding on behalf of the recipients are required to comply with the required accountability requirements, full details of these requirements can be found in the ILT Foundation Grant Accountability Policy.

Conditions of Entry:

- Recipients of the Scholarship are expected to act as ambassadors for the ILT Foundation and act in the appropriate manner to avoid the ILT Foundation's name being placed in disrepute.

Publication & Copyright:

- The applicant gives permission for the ILT Foundation to use images and support material submitted, in promotional material and publications for the scholarship and to be shown on the website, if required.

Directions to Applicants:

- Complete all details on the scholarship and attach relevant documents.
