- If you enter a designated gambling area of any ILT Foundation venue ticked on this form, before the expiry of the exclusion period, you commit an offence under the Gambling Act 2003.
- Such an offence is liable to a fine of up to \$500.
- The Venue Manager or person acting on the Venue Manager's behalf is required by law to remove you from the premises. The Police may be requested to assist in your removal.
- No prize money will be paid to an excluded person.

## DECLARATION:

- I confirm I understand that this order means I must not enter the gambling area of the venue(s) listed above whilst the order is in force.
- I understand that, if I do enter the gambling area of a listed venue during the exclusion period, I may commit an offence under the Gambling Act 2003.
- I understand that the venue(s) have a duty under law to keep a record of this order and may take steps to enforce exclusion.
